Strategies, Deductions, and Tools to Maximize Your Savings

Small Business & Self-Employed Deductions

- **1. Business Use of Home** Deduct part of rent, utilities, insurance, and depreciation based on square footage.
- **2. Vehicle Expenses** Choose between actual costs or the standard mileage rate. Keep solid mileage logs.
- **3. Equipment, Tools & Supplies** Section 179 allows immediate expensing of qualifying equipment; bonus depreciation may apply.
- 4. Advertising & Marketing Costs for website, business cards, ads, etc., are 100% deductible.
- 5. Professional Services Fees paid to accountants, lawyers, and consultants are deductible.
- **6. Interest & Bank Fees** Business-loan interest, equipment financing, and business bank fees are deductible.
- **7. Meals & Travel** 50% of qualifying business meals is deductible; travel (transportation, lodging) is deductible if business-related.
- **8. Taxes & Licenses** Business-license fees, state and local business taxes, and real-property taxes on business property are deductible.
- **9. Employee Credits (WOTC & Employer-Provided Childcare)** Work Opportunity Tax Credit for hiring from target groups; employer-provided childcare credit for businesses offering childcare to employees.
- **10. Retirement Contributions** SEP IRA, SIMPLE IRA, and 401(k) contributions are deductible; startup-cost credit up to \$5,000.
- **11. Research & Development (R&D;) Credit** For businesses that develop new or improved processes, products, or techniques.
- **12. Opportunity Zone Investments** Potential deferral or reduction of capital gains when investing in qualified zones.

Real-World Deduction Examples

- Home Office: If your home office is 200 sq. ft. of a 2,000 sq. ft. home, you can deduct 10% of rent and utilities.
- Mileage: Driving 12,000 miles at the 2025 IRS mileage rate of \$0.67/mile = \$8,040 deduction.

Recordkeeping Tips

- Keep receipts, mileage logs, invoices, and bank statements.
- Use MileIQ for mileage tracking and QuickBooks or Zoho Books for bookkeeping.

Commonly Missed Deductions

- Startup costs (up to \$5,000 in the first year)
- Continuing education
- Software subscriptions
- Bank & merchant fees

Expanded Credits

- Employee Retention Credit (ERC)
- Disabled Access Credit
- Energy-Efficiency Credits (e.g., solar, EV chargers)

Small Business Tax Calendar

- Jan 31 W-2/1099 due
- Apr 15 Return + Q1 estimated tax
- Jun 15 Q2 estimated tax
- Sep 15 Q3 estimated tax
- Oct 15 Extension due
- Dec 31 Last day for certain contributions
